About Us

Mahatma Gandhi Dental College and Hospital has earned recognition and reputation at the national level over the years, due to its focus and perseverance. Currently, it runs an undergraduate program- BDS with annual admission of 100 seats and postgraduate program- MDS with annual admission of 31 seats in 7 specialities. Both the undergraduate and post graduate programs are recognized by the Dental Council of India.

The college also runs the Post Graduate Certificate Course in Oral Implantology of 10 months duration, in association of Nobel Biocare, India with 15 admissions per batch. The College is also recognized by the Dental Council of India to run Dental Mechanics and Dental Hygienist Diploma courses with annual admission of 15 seats each.

The college is situated within the 36.5 acre University Campus located in the Institutional Area of Sitapura on the Jaipur-Kota Highway, 9 km from the Sanganer International Airport. The campus includes the Mahatma Gandhi Medical College and Hospital which is considered one of the premier medical institutes of the country. The campus boasts of green surroundings, Wi-Fi facility, sports and gym facilities hostels for students and housing for the faculty.

The college, with its student friendly and highly qualified faculty provides a congenial environment for the students to grow academically. The college shows zero tolerance to ragging and has a dedicated anti-ragging squad and committee to ensure a safe and comfortable atmosphere to the students.

The college is well equipped with advanced equipments and materials to cater the needs of patients for all types of dental treatments. Programs offered

BDS

This is an undergraduate degree program that focuses on providing quality oral health care to patients as well as assessment, diagnosing and treating oral conditions and problems.

BDS is a 4-year course and 1 year internship.

The curriculum includes

Clinical case studies and discussions

Clinical demonstration

Performing various restorations on phantom head and also on patients.

Workshops and seminars.

Number of Seats - 100

Categories of seats -

a. Management Category seats-15% of total

intake - 15 Seats

Management Quota seats shall be filled as per state reservation policy and preference will be given to Rajasthan state domicile. All India candidates do not require domicile certificate.

b. State Quota seats - 85% of total intake -85 Seats

The candidate must have passed 10+2 or equivalent examination in the subjects of Physics, Chemistry, Biology and English individually and must have obtained a minimum of 50% marks taken together in Physics, Chemistry and Biology at the qualifying examination as mentioned in the Dental Council of India Revised BDS Course Regulations 2007 as amended from time to time.

In respect of the candidates belonging to Scheduled Castes, Scheduled Tribes or Other

Backward Classes, the marks obtained in Physics, Chemistry and Biology taken together in

qualifying examinations shall be 40% marks instead of 50% marks for General category

candidates. In respect of candidates with Bench Mark Disabilities specified under the Rights of Person with Disabilities Act, 2016, the minimum marks in Physics, Chemistry and Biology (or Botany & Zoology) taken together in qualifying examination shall be 45% instead of 50% for General category candidates and 40% for SC/ST/OBC candidates.

The students educated abroad seeking admission in Mahatma Gandhi Dental college,

Jaipur must have passed in the subjects of Physics, Chemistry, Biology and English up to the 12th standard level with 50% marks and their equivalency determined as per regulations of the Dental Council of India and the University.

2. The candidate must have qualified National Eligibility cum Entrance Test NEET UG 2023.

3. The candidate must fulfill the admission criteria, eligibility, rank in merit list, medical fitness and such other criteria as may be prescribed by the Government of India, the Government of

Rajasthan and the MGUMST.

4. The candidate must have completed the age of 17 years on or before 31st December of the year of his/her admission to the 1st year BDS course.

5. The upper age limit of the candidate is 25 years on the date of NEET UG of the year of

admission with relaxation of 5 years for the candidates belonging to SC/ST/OBC category

and persons entitled for reservation under the Rights of Persons with Disabilities Act, 2016.

Reservation -

Reservation of the seats for respective categories shall be as per applicable Reservation Policy of Government of Rajasthan prevailing at the time of admission.

MDS

Masters program is designed to provide advanced education and training in various fields of dentistry.

Admission to MDS Courses in Mahatma Gandhi Dental College & Hospital (MGDCH), Jaipur - a unit of MGUMST, Jaipur for the academic year 2023-24 shall be governed by the:

1. Norms prescribed for entrance test (NEET MDS 2023) and counseling prescribed by National Board of Examinations (NBE) New Delhi, Ministry of Health & Family Welfare, Govt. of India.
2. Act and Statutes of Mahatma Gandhi University of Medical Sciences and Technology.
3. Directions / orders of Hon'ble Supreme Court of India from time to time.
4. Directions / Orders of Government of India and the Government of Rajasthan.

Only the candidates who have qualified the NEET-MDS 2023 shall be eligible for admission to the Postgraduate MDS Courses. Admissions shall be made on the basis of merit marks obtained by candidates at NEET-MDS 2023 conducted by the National Board of Examination, New Delhi.

Prospective candidates are advised to go through the 'Information Bulletin of NEET MDS 2023' for complete information regarding the examination conducted by National Board of Examinations (NBE) New Delhi, Ministry of Health & Family Welfare, Govt. of India and the counseling process for admissions in the institutes offering PG dental courses etc.

MGDCH, Jaipur has been offering various PG – MDS Courses which are duly recognized by Dental Council of India / Ministry of Health & Family Welfare, Govt. of India.

RESERVATIONS

Admission to MDS Courses shall be made as per the policy of the Govt. of Rajasthan prevailing at the time of Admission.

Eligibility

(A) No candidate of any category shall be eligible for admission to MDS courses in Mahatma Gandhi Dental College & Hospital, Jaipur if he/she has not qualified NEET-MDS 2023.

(B) Every candidate, being selected for admission to postgraduate dental course should possess.

1. BDS degree or Provisional BDS Pass Certificate recognized as per the provisions of the Dental Council of India.
2. Permanent or provisional registration certificate of BDS qualification issued by the State Dental Council.
3. Internship completion certificate showing the completion of the internship on or before 30th June 2023.
4. Qualifying certificate cum marks statement of NEET-MDS 2023 issued by the National Board of Examinations, New Delhi.

(C) Foreign Dental Graduates

Indian citizens or overseas citizens of India who have obtained their Primary Dental Qualifications from Dental Colleges outside India should have qualified the Foreign Dental Graduate Examination (Screening Test) which is conducted by National Board of Examinations. Further, they should have been registered with DCI/SDC and should have completed their internship on or before 31.07.2022.



(D) Foreign Nationals

1. It is not mandatory for foreign nationals to have temporary registration with DCI at the time of appearing at the NEET-MDS 2023. They can appear at the NEET-MDS without DCI registration. The Dental Council of India may, on payment of the prescribed fee for registration, grant temporary registration for the duration of the Post Graduate course limited to the Dental college - Mahatma Gandhi Dental College & Hospital, Jaipur to which he/she is admitted for the time being exclusively for pursuing postgraduate studies. Provided further that temporary registration to such foreign national shall be subject to the condition that such person is duly registered with appropriate registering authority in his own country where from he has obtained his Basic Dental qualification, and is duly recognized by the corresponding Dental Council or concerned authority.

2. Students from other countries should possess passport, visa and exchange permits valid for the entire period of their course of study in this Institution and should also observe the regulations of both central and state governments regarding residential permits and obtain no-objection certificate etc., from time to time.

3. The student should have a provisional "Student Visa". If he/she comes on any other visa and is selected for admission, he will have to first obtain a student visa from competent authority and then only he/she will be allowed to join the course. Therefore it is imperative

to obtain provisional student visa before coming for Counseling.

(E) Registration with State Dental Council (SDC)

1. Every student, selected for admission to a Post

Graduate dental course in Mahatma Gandhi Dental College & Hospital, Jaipur on acquiring BDS Degree or an equivalent qualification thereto shall have to obtain permanent registration with the DCI/SDC within a period of one month from the date of his/her

admission, failing which his/her admission to PG Dental Course in Mahatma Gandhi Dental College & Hospital, Jaipur shall stand cancelled.

2. For Foreign Nationals, Clause (D) as above shall apply.

PhD (Doctor of Philosophy)

This is doctoral level academic degree that represents the highest level of education and expertise in the field of dentistry.

As per the guidelines of the statutory regulating council i.e. Dental Council of India, a candidate for admission to the Ph.D. course in the Faculty of Dental Sciences must possess -

(i) a post graduate degree (MDS) in any dental subject from any approved Indian University/its constituent and affiliated college or recognized by Dental Council of India. Where marks are given in Masters course examination, the concerned candidate should have obtained at least 50% marks in the P.G. examination.

A relaxation of 5% in the minimum eligibility marks shall be applicable to the candidates belonging to the categories of OBC/SBC/S/C/ST/Physically handicapped.

(ii) a post graduate degree with 50% marks or equivalent grade from a foreign University deemed equivalent to MDS degree of this University. No Objection Certificate from the Dental Council of India will however be required in these cases.

(iii) a teacher of this University or working in other recognized University or in a recognized constituent/affiliated college - possessing eligibility conditions as at

(i) above shall also be eligible for admission in Ph.D. programme provided -

a) his supervisor shall be a faculty of Mahatma Gandhi University of Medical Sciences & Technology.

b) his place of work shall be the concerned department of the respective college of this University and the department of the co-supervisor (if any), if the co-supervisor is from any other institution/centre of repute.
